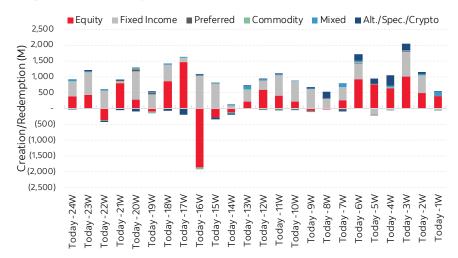

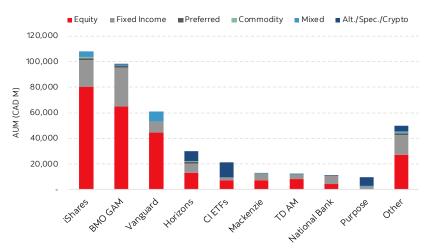

The five largest providers account for 77% of the ETF Canadian landscape



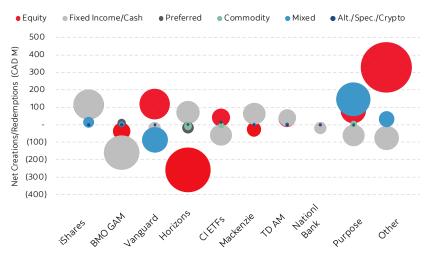
